Apologies for absence were received from Mr M Davis

Declarations of interest: Cllrs Wilson and Thornton declared themselves members of reVOLT and Cllr Thornton a member of VETO but no financial gain was involved .

2. The Minutes of the meeting held on 6th February 2017 were read and approved.
3. **Matters Arising from the Minutes**
 - 3.1 Footpaths: An email has been sent to Beeswax requesting a meeting in mid April 2017 to discuss footpaths and bridleways in Stubton following the completion of the year's "trial".
 - 3.2 Straw Storage at Fulbeck: This planning application has been granted but with 13 conditions, many of which, it was felt should have been addressed by the applicant before approval; eg all straw bales should be netted to help improve mess; a cleaning programme should be commenced in Stragglethorpe and on the A17. Cllr Sampson informed the meeting that he had written to the Planning Committee asking why these matters had not been addressed.
 - 3.3 Roads: The two large potholes in the centre of Stubton had been repaired and a thank you note written. Numerous other areas on local lanes have been marked out for repair, hopefully for work to be done very soon.
 - 3.4 Litterpick: Cllr Thornton thanked all who participated in the annual litterpick – it was an excellent turn out and there was far less litter to collect than in previous years.

4. **District Councillor Sampson**

- 4.1 Roads: Regarding road repairs in and around Stubton, Cllr Sampson informed the meeting that **Claypole Road, Brandon Road and Cherry Lane** will be closed for 4 days at some point between the 10th April and the 24th April for repair. Local diversions will be signposted and access will be available. The Clerk will inform the village.

Cllrs Sampson and Wood have grave concerns over the quality of the repairs to roads that are being carried out, particularly relating to pothole filling and are taking this matter up with Highways.

- 4.2 Local Plan: the Local Plan which will run until 2036 is progressing on programme with a view to it being presented to the Secretary of State in September 2017. A Public Consultation on the latest model will be held in Long Bennington on the 22nd June 2017 from 1pm to 7pm.
- 4.3 Cllr Paul Wood will be standing for re-election at the Local Elections on the 4th May 2017 – literature has been circulated in Stubton.

5. **Fulbeck Wind Farm; EnergieKontor**

Cllr Thornton, as a representative of VETO, informed the meeting that it was hoped an answer to this Planning Application would be available very soon.
